WITH RESPECT TO ECONOMIC DEVELOPMENT REVENUE BONDS (STERLING WESTCHESTER APARTMENTS PROJECT)

Notice is hereby given that a public hearing ("Public Hearing"), as required by Section 147(f) of the Internal Revenue Code of 1986, as amended ("Code"), and Chapter 43 of Title 41 of the Code of Laws of South Carolina 1976, as amended ("Act"), will be held by the South Carolina Jobs-Economic Development Authority ("Authority") with respect to above-referenced bond issuance by the Authority. The hearing will commence on October 6, 2022, at 11:00 a.m., or as soon thereafter as the matter can be heard, and will be held telephonically by the Authority.

The Authority previously issued its Economic Development Revenue Bonds (Sterling Westchester Apartments Project) Series 2021, in an aggregate principal amount of not exceeding \$2,850,000 ("Bonds") and loaned the proceeds of the Bonds to FAH Westchester, LLC, a Delaware limited liability company (the "Borrower"), the sole member of which is the Foundation for Affordable Housing, a nonprofit corporation and organization described in Section 501(c)(3) of the Code. The Borrower used the proceeds of the Bonds to (i) finance a portion of the costs of the acquisition, rehabilitation and improvement of a 116-unit, affordable multifamily housing development located in Greenville County, South Carolina and known as Sterling Westchester Apartments ("Project"), (ii) fund certain accounts and funds related to the acquisition and rehabilitation of the Project and the issuance of the Bonds, and (iii) provide for the payment of certain fees and expenses expected to be incurred in connection with the issuance of the Bonds.

The Project is located at 300 Pelham Road, Greenville, South Carolina 29615. The Project is owned and operated by the Borrower.

The Authority and the Borrower desire to undertake certain changes which will result in a reissuance of a portion of the Bonds in the aggregate principal amount of \$1,650,000. The Bonds are special, limited obligations of the Authority payable solely from the loan repayments to be made by the Borrower to the Authority pursuant to the Loan Agreement dated as of October 1, 2021, (as may be amended, supplemented or restated) between the Borrower and the Authority and certain funds and accounts established under the Trust Indenture dated as of October 1, 2021 (as may be amended, supplemented or restated), with respect to the Bonds.

The Bonds will not constitute a general obligation or indebtedness of the Authority, the State of South Carolina ("State") or any other governmental entity within the meaning of any state constitutional provisions (other than indebtedness payable only from a revenue-producing project or special source within the meaning of Article X, Section 13(9) of the Constitution of the State, 1895, as amended) or statutory limitation nor give rise to a pecuniary liability of the Authority, the State or any political subdivision thereof. The Bonds will not constitute a charge against the general credit of the Authority or the State or the taxing powers of the State. The Authority has no taxing power.
